

PREFACE

The present volume is the outgrowth of a dissertation which I submitted in partial fulfillment of the requirements for the Degree of Doctor of Philosophy in the Department of Religious Studies, Brown University, April, 1974. I have further researched various aspects of the subject, expanded or developed the discussion of particular problems, and refined and revised the text.

I could not have completed this work without the direct and indirect help of many individuals. I owe special thanks to Professor Jacob Neusner, of Brown University, in whose seminar I read early drafts of this work. In and outside of class, he generously gave of his time and guidance, and offered me the benefit of his experience and erudition. Every page of this study has been enriched by his criticism and suggestions. Moreover, this work takes up his suggestion, raised in the *History of the Jews of Babylonia*, that Samuel had some type of sustained effort at interpreting Mishnah.
