Alfred Arteaga is an Assistant Professor of English at the University of California, Berkeley. He is the author of *Cantos* (1991) editor of *An Other Tongue*, forthcoming from Duke University Press.

Sergei S. Averintsev has held appointments at Moscow State University, the Institute of World Literature of the Russian Academy of Sciences, and the Russian State Humanities University. A distinguished classicist and philosopher, he has also published numerous works on Bakhtin.
