**Pınar Akçali** was born on October 19, 1965, in Ankara. She graduated from the Department of Political Science and Public Administration of the Middle East Technical University (METU), Ankara, in 1987. Following her graduation, she went to the Bologna Center of the Johns Hopkins University in Italy for a “one-year diploma program” in international relations. She has publications in Turkish and in English on Central Asian identity issues.

**Shirin Akiner** is Lecturer in Central Asian Studies at the School of Oriental and African Studies, University of London, where she convenes and teaches courses on Central Asian history, politics, and religion. She is also an Associate Fellow of the Royal Institute of International Affairs, London. She has extensive firsthand experience of the region. He was on mission in Central Asia (1957) when in the Secretariat of the United Nations, and has often returned to the region. He is chairman of the Advisory Board on Central Asia and the Caucasus of the Royal Institute of International Affairs, London, and author of many publications on the region, including ‘The Economies of Kazakhstan and Uzbekistan’ (RIIA, 1997); he is contributing two chapters on Central Asian economic history to ‘The Cambridge History of Inner Asia’ (CUP, forthcoming).

**Anatoly Krutov** is Operations Officer for Water and Environment at the World Bank office in Tashkent, Uzbekistan. He has extensive experience in areas such as environmental protection, water management, irrigation and drainage in the Aral Sea Basin, and has a background in hydraulic engineering and environmental management. Before joining the World Bank, he was Head of Department in the Central Asian Scientific Institute of Irrigation (SANIIRI) in Tashkent, and worked in a comparable position in the Syr Darya Water Basin Authority.
