Manuscripts should not normally exceed 112,000 words exclusive of bibliography. Contributions should be submitted electronically to the editor by e-mail to:

paolo.sartori@oeaw.ac.at

Notes about fonts and any non-standard fonts must also be submitted.

The text must be formatted with 1.5-inch margins and be double-spaced. To assure anonymity, there should be no reference to the author anywhere in the text or the notes. A separate cover sheet must be included with the manuscript title, author's name, professional affiliation, complete mailing address, and telephone number.

Abstract and key words: Abstracts in English, not to exceed 100 words, should accompany each submission. Five key words (in English) should be included with the abstracts.

Contributors will be provided with e-offprints (PDF files) of their articles or reviews after publication.
